### **Description:**

Pregnancy is one of the highest risk times in life for women's oral health. Oral disease in pregnant people not only affect their overall health, but also pose risks to their growing baby. Furthermore, after the baby is delivered, the mother's oral health continues to affect the new baby. In this presentation, Dr. Tim Ricks, DMD, MPH, FICD, FACD, FPFA, discusses the importance of oral health (dental) care in pregnancy and postpartum, how to screen pregnant people and babies for oral disease, when it is appropriate for the pregnant person to receive dental care, and good oral hygiene practices in pregnancy, post-partum, and for the newborn infant. Then Dr. Miranda Davis, DDS, MPH, and Pamela Ready, RDH, share how Dental Health Aides (DHAs) are serving an essential role to provide oral healthcare services to the pregnant and post-partum person and the newborn child. The new Care and Access for Pregnant People ECHO Program includes an opportunity to engage in a didactic presentation, gain insight on how I/T/U facilities may effectively integrate timely pregnancy care, and become part of a learning community.
